The second CWG meeting began with introductions of new members and re-introductions of members who attended the first meeting. A two-part question was proposed to get the discussion started: Who uses transit now and when might you use it? Results of the discussion are provided below.

Who uses transit now?

- Non-drivers and those who cannot drive
- Commuters
- Those who do not want to deal with traffic
- Those who are out drinking
- Environmentally conscience
- Bike to transit users
- Attendees at special events/sporting events/etc.



When might you use transit?

- When told not to drive because of increase in volume or safety reasons
- When going to Center City for special events (i.e. sporting events, restaurants, shows, parades, etc.)
- When going to the airport
- When the weather is bad
- Commute into the city
- Economic benefit
- Do not have to worry about parking
- More reliable
- Bike to stations
- Environmentally conscience

After the warm-up exercise, a presentation was given on the NEPA process and how it relates to the KOP Rail project. Several questions arose about the make-up of the other committees and who sits on those committees. As a follow-up item, a list of committees was emailed to the group to inform them of what entities are involved. CWG members are not invited to participate at other committee meetings..

There were many questions and requests to have the UMT Supervisors and other elected officials present. The UMT Supervisors are aware of these meetings. An open invitation will be sent to them moving forward.

The group requested more information on ridership, where the riders are coming from and going to, and where the information that is being used in the ridership model comes from. Ridership and the ridership model will be a main topic at a future CWG meeting.

There was some discussion about the No Action Alternative not being effective. The No Action Alternative is not effective compared to the Purpose and Need of the King of Prussia Rail Project which can be found on the project website: www.kingofprussiarail.com.

There was a request for photos being taken at a house in Brandywine Village and a rendering be produced. SEPTA and McCormick Taylor will have photos taken at that residence and determine if the structure will be seen from that location.
